YOUR DAY BY DAY ITINERARY

Day 1: Oct. 12 SAN DIEGO / MEXICO CITY / PUEBLA

Our journey begins as we board our international flight to Mexico City. Upon arrival, we are warmly greeted by our tour escort and escorted to our deluxe motorcoach for a scenic transfer to Puebla, known for its rich colonial history. Dinner and overnight in Puebla. (D)

Day 2: Oct. 13 PUEBLA

We start the day with a Mass at the stunning Rosary Chapel, one of Puebla's most exquisite baroque treasures (subject to confirmation). Our tour continues with a visit to Puebla's impressive Cathedral and the Church of San Francisco, where we can view the incorrupt body of St. Sebastian. The afternoon is at your leisure to explore Puebla's charming streets and local culture. Dinner and overnight in Puebla. (B/D)

Day 3: Oct. 14 PUEBLA / MEXICO CITY

After breakfast, we depart for Mexico City, stopping at two revered pilgrimage sites along the way. First, we stop at the Shrine of San Juan Miguel del Milagro, home to the miraculous spring of healing waters where you can collect holy water. Then, we travel to Ocotlan where Our Lady appeared to Juan Diego, leaving her image on an oak tree, now enshrined in the beautiful Sanctuary of the Virgin of Ocotlan. We celebrate a Mass there (subject to confirmation). Next, we transfer to Mexico City where we enjoy a city tour around the Zócalo area. Dinner and overnight in Mexico City. (B/D)

Day 4: Oct. 15 MEXICO CITY

We begin the day with a visit to the Plaza of the Three Cultures, a site symbolizing the fusion of Mexico's pre-Hispanic, colonial, and modern heritage. Our next destination is the awe-inspiring Pyramids of Teotihuacan, where ancient civilizations erected massive structures dedicated to their gods. In the afternoon, we celebrate a private Mass at the Basilica of Our Lady of Guadalupe, one of the most visited Catholic shrines in the world (subject to confirmation). A tour of the Basilica will follow. Dinner and overnight in Mexico City. (B/D)

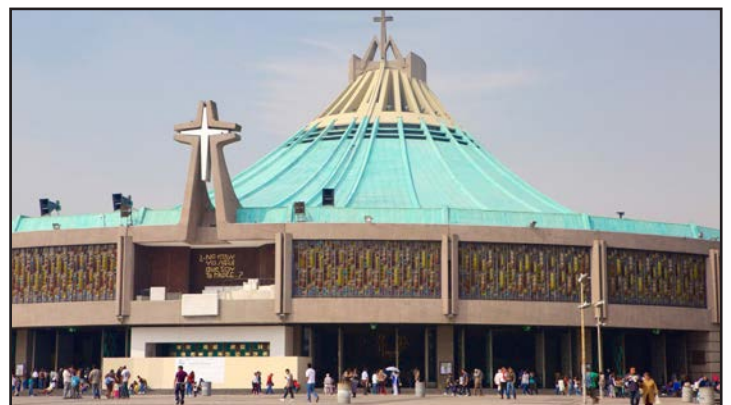
Day 5: October 16 MEXICO CITY

Today, we explore the vibrant neighborhood of Coyoacan, known for its art, history, and colorful architecture. We'll visit the Church of St. John the Baptist and then continue to Xochimilco, a UNESCO World Heritage Site famous for its scenic canals. We will celebrate Mass at the Church of San Bernardino (subject to availability) before embarking on a traditional gondola ride with lunch on board. Afterward, you'll have some free time to relax and explore. Dinner and overnight in Mexico City. (B/L/D)

Day 6: October 17 MEXICO CITY / SAN DIEGO

After breakfast, we transfer to the airport for our flight back to the USA, arriving the same day. Reflect on the profound spiritual experiences of this pilgrimage as you return home with memories that will last a lifetime. (B)

TERMS AND CONDITIONS

Tour prices: All prices in this brochure are based on airfares, land rates and exchange rates in effect at the time of printing and on group rates of 30 passengers or more. Tours may depart with less than the required number of passengers, at the discretion of Group IST, LLC (doing business and referred to therein as "Regina Tours"), but an additional charge may apply. Passengers will be advised about such surcharges 60 days before departure. All prices are subject to change without notice prior to departure due to major currency fluctuations, changes in fuel prices and/or unforeseen economic circumstances.

Reservations, Deposits and Final Payments: Please complete the Participant Agreement, with full names as they appear on passports, and mail it to us with the required per person deposit plus applicable (optional) insurance. Receipt of your deposit shall act as your agreement to these terms and conditions. Balance is due 75 days before departure date. If final payment is received less than 75 days, a late fee will be assessed in the amount of \$50.00. If final payment is made by credit card (American Express, Visa, MasterCard), Regina Tours requires a completed credit card authorization form. All payments made by check should be made payable to Regina Tours.

Late Reservations: If a booking is made within 60 days of departure, full payment plus applicable taxes and optional insurance is due at the time of booking. There will be a \$50.00 late processing fee applicable plus cost of any express or overnight mail services. No personal checks will be accepted with reservations received 30 days or less before departure date. Money order, bank check, certified check or credit cards (American Express, Visa, and MasterCard) will be accepted.

Travel Documents: A valid passport (valid for six months after the return date of the trip) is required to travel. Visa is required for US passport holders traveling to some destinations; please contact our office for details. All non-US citizens must contact the appropriate consular office for entry visa requirements pertaining to their trip. In addition non US citizens are responsible for complying with requirements for re-entry into the USA. Regina Tours assumes no responsibility for procurement of passport or visas. Obtaining and carrying these documents is the sole responsibility of passengers. Regina Tours will not be responsible for any delays, damages and/or losses, including missed portions of your trip due to improper travel documentation.

Final Documents and Tickets: All documents and tickets are only issued upon receipt of final payment and are sent within 3 weeks of departure. Documents and tickets are not guaranteed if final payment and booking form are not received on time.

Air from Home City: All brochure departures are based on a New York area airport. Regina Tours can help arrange air transportation from your home city airport. Regina Tours is not responsible for any penalties incurred on domestic tickets not purchased from us, in case of changes in the schedule of the tour. If you are making your own domestic airline tickets, please make sure that your domestic flight time arrives at least 4 hours prior to your international departure time.

Air Changes, Cancellations & Refunds: Airline tickets issued by Regina Tours are highly restrictive and in most instances cannot be reissued, revalidated or exchanged. If a change is possible, a \$75 per person administrative fee, plus any applicable airline change fees, will be assessed once air tickets have been issued. Airline penalties vary depending on carrier.

Airline Seat Assignments and Special Services: There is no advance seat selection. Early check-in is necessary to secure seats with travel companions. Seating is solely under control of the airlines. Some airlines used may be eligible for frequent flyer mileage.

Baggage: The company is not responsible for any additional charges collected by the carriers at the airport for luggage fees. We recommend that you take along one suitcase per person with a maximum weight of 50lbs., plus one carry on with maximum dimensions of 9"X14"X22". Airlines also have their own baggage restrictions; please check with the air carrier prior to your departure. All baggage is the passenger's responsibility throughout the tour. Regina Tours is not responsible for loss, theft or damage to your baggage. If a bag is lost or damaged In-flight, the passenger is responsible for notifying the airline directly.

Airline Clause: The airlines concerned will not be held responsible for any act, omission, or event during the time passengers are not aboard their aircraft. The passenger tickets in use by the airline, when issued, shall constitute the sole contract between airline and the purchaser of these tickets and/or passenger. These tours may be sold in connection with the services of any ATC or IATA Airline.

Rooms: Prices shown in the brochure are per person, based on two persons sharing a hotel room or cabin. A limited number of single rooms are available at the supplement shown per tour. In some cases, when requested, we may be able to find an appropriate roommate for passengers who have booked as a single person. **If a roommate is not available, you must pay the single room supplement.** While single rooms provide privacy they are often smaller than twin bedrooms. Triple rooms are available in many hotels for family or friends traveling together. There are no discounts for triple rooms.

Medical Conditions: While we endeavor to provide the highest level of service to all our passengers, we cannot guarantee special facilities or assistance for disabled passengers and it is your responsibility to arrange for such assistance as required. We regret that we cannot provide individual assistance Regina Tours is not responsible for any medical conditions that may occur prior, during, or after the tour.

Land Only Bookings & Tour Deviations: All Regina Tours packages include airfare from the city designated. Land only bookings will be invoiced based on adjusted price. Arrival and departure transfers are not provided for land only bookings. Any deviations from the tour, requested by the client, will be assessed a charge of \$100.00 per person, plus any additional costs the change may incur.

However, should you need to cancel, your cancellation must be received in writing, via email, fax or by letter. It will be effective on the date of receipt. If you cancel your tour after you have received your documents and airline tickets, you must return them to Regina Tours before we can process your refund.
